


Tools needed (not supplied):

- Cordless drill
- Phillips screwdriver

- Self-tapping screws (4)
- Plastic anchors (4)

1 Installing the Mounting Base

- Inspect the site where you want to install the camera. The mounting surface must be flat and capable of supporting at least three times the weight of the camera.
- Remove the mounting base from the camera enclosure by pressing the triangle on the enclosure and pulling the two pieces apart.
- Hold the mounting base up to the mounting surface and mark the screw hole positions and a center hole for cabling.
- Drill holes at the marked locations and insert the supplied plastic anchors into the screw holes.
- Pull the power and video cables through the center hole.
- 6. Attach the mounting base to the mounting surface using the supplied screws.



2 Mounting the Camera

- Connect the power and video cables.
 - Connect the power connector of the camera to a 12 V DC power source.
 - b. Connect the BNC connector of the camera to a coaxial video cable.
- Push the camera enclosure onto the mounting base until it clicks into place.

3 Aiming the Camera

Rotate the camera enclosure and camera body to set the desired camera position.
